**1. ABOUT THE INSTITUTE**

Indian Institute of Information Technology Bhagalpur (IIIT Bhagalpur) is an Institute of National Importance set up by Ministry of Education (MoE), Govt. of India in Public-Private-Partnership (PPP) mode. The institute offers the B.Tech, M. Tech and Ph.D. program (s) in the Computer Science & Engineering, Mechatronics & Automation Engineering, Electronics & Communication Engineering, Mathematics & Computing, and Basic Science and Humanities Department.

**2. Engagement of Guest Faculty at IIIT Bhagalpur**

- (a) The Institute invites applications from Indian nationals in the prescribed format for engagement of Guest Faculty.
- (b) The applications are invited for engagement of Guest Faculty in the **Department of Computer Science and Engineering** on purely temporary basis initially for one semester, which may be extended maximum for two more semesters based on the performance and requirement. - (b) Application form without relevant supporting enclosures shall be summarily rejected. No correspondence shall be entertained in this regard.
- (c) All degrees mentioned in the application should be awarded by an Institute/ University recognized by the Government.
- (d) Mere fulfillment of minimum qualification and experience requirements does not entitle any candidate for a call for interview. A short listing criterion may be set higher than the minimum advertised.
- (e) The Institute reserves the right to call all the eligible candidates or short listed candidates for interview after screening by the Institute. The Institute also reserves the right to defer or cancel the selection process without assigning any reason thereof. The decision of the Institute in this regard will be final and binding on all the applicants who respond to this advertisement. No interim communication on the status of application will be entertained.

- (g) Shortlisted/eligible candidates will be called for interaction and informed through email regarding the date, time, and venue. No TA/DA shall be admissible in this regard.
