With reference to Advt. No. Advt/08/2022/SHI/1373 dated 31/12/2022 & Tender No. REG/SHI Tender/279/2022/21/1376, dated 31/12/2022, the Pre-bid meeting of Group Medical Insurance of Students of IIIT Bhagalpur was held in conference room of admin building of IIIT Bhagalpur on 5th January 2023 from 11:00 AM onwards.

The following changes are applicable in the tender document as per the queries received in the pre-bid meeting:

1. Dental/cosmetic treatment should be excluded from the scope of the Insurance policy.
2. 10% Co-pay is applicable in case of claim intimation delayed by more than 30 days.
3. Third party administrator duly licensed by Insurance Regulatory and Development Authority (IRDA) is allowed to serve the claim Cashless facility and reimbursement of claims to insured persons.
4. The bidder must provide list of empaneled Hospitals in Bhagalpur city and Bihar. All India list will have to be submitted after award of the tender.
5. EMD submission for IRDA empaneled insurance companies is exempted.
6. No. of students as per age-group instead of percentage will be as follows:

Age Group	16-23	23-28	28-35
No. of Students	685	26	14

7. Any reimbursement claim should be settled within 30 days of submission of complete documents by the student to avoid penalty as per tender document.
8. For room rent & ICU limit proportionate clause will not be applicable.
9. Instead of 10 thousand of OPD facility to each student, OPD CAP of 35 lakhs will be applicable where any student can avail maximum up to 10 thousand for OPD treatment.
10. Insurance broker firm is not allowed to participate in the tender process.
11. Date of commencement of policy will be the date and time of premium remittance.
12. For the clause 9 of the tender document, new joinees would get cover under the policy on payment of proportionate additional premium for the remaining policy period. They would get cover the moment proportionate premium is remitted.
13. For clause 7 of the tender document, if any student is referred to an outside specialist doctor for consultation or treatment the same would be reimbursed provided the hospitalization/OPD treatments are done as per the policy coverage.
14. For clause 11 of the tender document, documents for reimbursement by the student should be submitted within 30 days to avoid co-pay.

16. The last date of tender submission has been extended upto 13th January 2023, 04:00 PM.
